

FVA ASKS CPSA FOR "MEASURED" REGULATORY RESPONSE POST-CHAP

n a September 11th letter to the **Consumer Products Safety** Commission (CPSC) Chairman Elliot Kaye, organizations including FVA, SPI, VI and RFCI encouraged CPSC to promote a "measured and thorough regulatory response concerning the continued affordability and availability of the common plasticizers/phthalates deemed essential and safe ingredients in the commerce of flexible vinyl applications and product categories, which number in the thousands, inclusive of military articles, medical devices, automotive parts and fabrics, wire and cable, commercial roofing, industrial flooring, home and wall coverings, and myriad recreational products such as boats and rafts, and, toys."

The letter addressed the Chronic Hazard Advisory Panel (CHAP) study on phthalates in children's toys, commissioned in 2008 by federal statute. The CHAP Report was released on July 18th.

The FVA letter to Chairman Kaye was in response to a Congressional letter of August 1st that stated that "the CHAP's findings are alarming...and that although the statute requires CPSC to act within 180 days, we urge you to move forward... without delay." As FVA commented, "a careful reader of the CHAP report would **not** find the conclusions 'alarming' - the CHAP did recommend lifting the restriction on DIDP - a recommendation we can agree with, and made other recommendations which we would like to see scrutinized during a comment period, but there is certainly no cause for alarm as posted in the Congressional letter." ADVOCACY IN ACTION

American Chemistry Council (ACC) to Work with the US Green Building Council (USGBC)

Issues surrounding "Green Building" standards continue to percolate throughout the vinyl value chain. While much is happening on this front, there are continued questions regarding the validity of the US Green Building Council (USGBC) employing "Red Lists" in the latest iteration of its guidance, known as LEED v4. The American Chemistry Council (ACC) has committed to a new initiative designed to ensure the use of sustainable and environmentally protective products in buildings by applying technical and science-based approaches to the LEED green building program. This new initiative acknowledges USGBC's success in leading the transformation of the built environment and establishes a pathway to access the materials science expertise within ACC and its membership.



"USGBC and ACC share the goal of advancing sustainability in the built environment, and we will work together to take advantage of our collective strength and experience," said Rick Fedrizzi, President, CEO and Founding Chair of USGBC. "The looming impacts of climate change and the possibilities of improving human health and well-being favor collaboration and engagement as key strategies. The goal is forward progress."

It is believed that USGBC, as the leader of the green building movement, combined with the scientific expertise within ACC, can develop a path to stronger, scientific-based standards that achieve measurable progress in sustainability.

On June 11th, FVA presented the final FVA White Paper: *Case Study of a Phthalates Alternative Assessment for Use in PVC Jacketed Network Cable* to the EPA's Design for the Environment (DfE) officials. This concluded a 15-month priority project for FVA and offered EPA an example of the complexity and considerations surrounding the formulation change of a safe and functional ingredient.

There are no estimates for EPA DfE publication of its Alternatives for Certain Phthalates Partnership report. During the meeting, FVA requested inclusion of the White Paper in the appendix of the EPA DfE report when it's published.
