

FVA FILES COMMENTS ON CPSC PROPOSAL TO REGULATE PHTHALATES

ollowing a successful appeal for an extension of the comment period until April 15th, the FVA and allied industry groups filed comments to the Consumer Products Safety Commission (CPSC) on a Notice of Proposed Rulemaking addressing the continued use of phthalates in children's products. As noted in FVA's comments, "this Notice of Proposed Rulemaking (NPR) will unfortunately lead manufacturers of 'children's products' to face further uncertainty in attempting to revise product formations (upping their manufacturing costs), be subject now to increased product liability concerns, and have one more regulatory compliance burden placed on their shoulders as

manufacturers, small and large of such consumer goods suitable for children."

FVA members will be kept apprised of the publication of the Final Rulemaking, which may take several months to issue based on the substantial number of comments received by CPSC on this matter and the questionable methodologies employed by CPSC to reach a decision that seeks to further regulate common plasticizers.

Vinyl Saves Lives at NPE

The plastics/vinyl industry raised in excess of \$7,000 for the American Red Cross Ebola Relief Campaign during the NPE 2015 show last month.

During the NPE event, the combined efforts of the vinyl trade groups along with a dozen corporate sponsors, designed and displayed the Vinyl Saves Lives exhibit, featuring vinyl products used in medical and health care settings inclusive of patient isolation tents, biohazard suits, blood bags, breathing masks, blood pressure cuffs and dialysis equipment. The display also included vinyl flooring and wall coverings used in typical hospital rooms.

The success of fundraising efforts was significant. The audience for the exhibit and campaign is estimated at more than 300,000 people in and outside of the plastics industry.

Proposition 65 Insurance Product Announced

Navigating California's Safe Drinking Water and Toxic Enforcement Act of 1986—better known as Proposition 65—is becoming an increasingly difficult endeavor for California-based companies, as well as companies doing business in the State of California.

Because Proposition 65 allows for private causes of action and the recovery of attorneys' fees, there has been a steady stream of claims alleging Proposition 65 violations, particularly now that common vinyl plasticizers such as DINP have been "listed."

What companies may not

realize is that they will soon have the option to purchase insurance to cover their costs of defending against and responding to "bounty hunter" suits. In a major industry announcement, SPI, the plastics industry trade association, will offer a "Prop 65 Protection Program" developed to inform, aid and protect retail and industry companies. Prop 65 California Chamber Letter on Labeling


FVA signed off on a coalition letter in early April prepared by the California Chamber of Commerce. The letter points out the deep flaws in the latest attempt by the State of California to "help" businesses by clarifying warning labeling requirements. As stated in the letter, the enhanced warning label proposal for 12 chemicals, inclusive of phthalates, would open up "new frontiers" of "bad warning" enforcement putting businesses at risk for more lawsuits.

The 73-page comment letter from the California Chamber and coalition includes more than 170 California-based and national organizations and businesses of varying sizes that, collectively, represent nearly every major business sector on which the ill-

advised proposal would have an impact. The California Chamber of Commerce should be applauded for their work on this on industry's behalf.
