GSA Recognizes GBI's Green Globes for New Construction and Sustainable Interiors

he Green Building Initiative (GBI) was bolstered by the recent decision by the US General Services
Administration (GSA) on

November 15th to recognize GBI's *Green Globes* certification as a permitted certification program for use in GSA's federal leasing activities.

This decision came after the GSA's Office of Leasing completed a months-long review and update of its leasing documents. The revised documents were finalized October 12th and were recently made available on GSA's website www.gsa.gov.

The revisions to GSA's Request for Lease Proposals (RLP) and lease templates recognize *Green Globes* for new construction and as an option for new leased spaces where green building certification is required for any building over

10,000 square feet.

The majority of federal agencies occupy leased space. The use of *Green Globes* provides the market with another option, beyond LEED, to make the footprint of green building-certified space more economical. The GSA Office of Leasing is a growing segment of the GSA's work within the federal footprint. Over the past decade, the GSA's percentage of owned versus leased federal office space has shifted with the Office of Leasing now overseeing about 51 percent of the total federal government portfolio.

ADVOCACY IN ACTION

Comprehensive Industry Response to Phthalate Petition at FDA Continues

A Food Additive Petition (FAP) was filed by a group of NGOs (multiple environmental and citizens lobbies) last spring and calls on FDA to revoke a number of the existing regulatory clearances for 30 ortho-phthalates, some of which are used in food packaging and processing applications.

The FAP requests that these ortho-phthalate clearances be revoked on the basis that the substances are not safe under their permitted conditions of use. Through the Ortho-Phthalates Coalition (OPC) managed by FVA, steps have been taken to respond to the NGO's FAP. Comments were filed September 12, part of the hundreds now on public record, addressing a number of deficiencies and errors in the NGOs filing, and specifically demonstrate that the NGOs:

- (1) incorrectly group all ortho-phthalates into one chemically and pharmacologically related class of compounds, and therefore wrongly assert that dietary exposures to all ortho-phthalates should be considered cumulatively;
- (2) incorrectly calculate and apply the Acceptable Daily Intake (ADI) level cited in the FAP; and.
- (3) incorrectly estimate the current dietary exposures for ortho-phthalates.

As a next step, FVA intends to submit a separate FAP to FDA on behalf of the Ortho-Phthalates Coalition that requests the Agency revoke the existing clearances for most of the ortho-phthalates that are the subject of the NGO FAP on the basis of abandonment of use. A survey is under development by OPC counsel and will be issued in early 2017, and will inform the specifics of the abandonment petition.

EPA Selects First 10 Chemicals for Risk Evaluation Under New TSCA

The EPA recently publicized, ahead of schedule, the highly anticipated list of chemicals selected for risk-evaluation under the new TSCA law, the Frank R. Lautenberg Chemical Safety for the 21st Century Act. This is an important milestone in implementing the new law and will likely prove to be the beginning of an iterative process. The chemicals all come from the 2014 EPA Workplan as required by law. The first ten chemicals to be evaluated are:

1,4-Dioxane
1-Bromopropane
Asbestos
Carbon Tetrachloride
Cyclic Aliphatic Bromide Cluster
Methylene Chloride
N-methylpyrrolidone
Pigment Violet 29

Tetrachloroethylene (also known as perchloroethylene) Trichloroethylene

Some of the criteria important to the EPA in selecting chemicals for the work plan continue to be concern for children's health, neurotoxicity, persistence/bioaccumulation/toxicity (PBT), carcinogenicity, use in children's products and detection in biomonitoring programs or in drinking water.
